



# PACIFIC INDEX EDGE

A Deferred, Fixed Indexed Annuity

Using hypothetical S&P 500<sup>®</sup> index returns of 12%, 4%, and -4%, the following examples compare two different Interest-Crediting Options available with the 7-year withdrawal charge on this product.

## Point-to-Point with Cap Option

1-Year Index Term, S&P 500<sup>®</sup> Index

A positive index return is credited to your contract, up to the cap, at the end of the one-year index term.

**Cap 5.00%**

Hypothetical Index Return	Interest Credited	Contract Value After 1 Year
12%	5.00%	<b>\$105,000</b>
4%	4.00%	<b>\$104,000</b>
-4%	0.00%	<b>\$100,000 (no loss)</b>

A cap is the maximum interest that can be earned if the return exceeds the cap. If the index return is flat or negative no interest is credited to the contract and there is no loss. The cap is set at contract issue and applies for the length of the index term.

## Participation Rate with Spread Option

1-Year Index Term, S&P 500<sup>®</sup> Index

A percentage of a positive index return, minus any spread amount, may be credited to the contract at the end of the one-year index term.

**Participation Rate 68%**

**Spread 2.00%**

*(Index Return x Participation Rate) – Spread = Interest Credited*

Hypothetical Index Return	Interest Credited	Contract Value After 1 Year
12%	6.16%	<b>\$106,160</b>
4%	0.72%	<b>\$100,720</b>
-4%	0.00%	<b>\$100,000 (no loss)</b>

The participation rate and spread are set at contract issue and apply for the length of the index term. If the index return is flat or negative no interest is credited to the contract and there is no loss.
